- Kristen at the Township requested terms for the new park board members. New members will be approved at the meeting tomorrow.
- Turnbridge path done.
- The work on the new Dudley Memorial shelter has been pulled back; still needs stain and shingles.
- Looking at grants for Wilhelmina Park. Working to partners with some agencies.
- Allen Estates HOA – they are interested in taking care of mulching, trees, flower beds and mowing. The Township is working out the details.
- The Liberty Playland 20th Anniversary had minimal attendance.

New Parks Business:

- Daughters of the Revolution – Michel will ask Paul Stumpf about members planting flowers around the cabin at Dudley Woods.
- Volunteers – Michel tried to solicit Lakota Schools for volunteers.

Continuing Parks Business/ Updates:

- Creek Walk with Lyn White – 33+ people in attendance. People asked about other family events.
- Sunset Yoga – New yoga instructor only getting one or two attendees. It will be up to the Y to keep it going.
- Fall Festival Parks Committee booth – Sept 28 – Ted, Paul, Kim and Laurie; Cleo and Michel are “possibles”; Bill will be out of town. Dave will come to drop off the plants. This year, there will be three rows of vendors, inflatables, only a couple of games.
- Heritage Days Sept 7– another meeting to follow up. It seems to have gone well. 3 paintings were sold. Would like to do it again; it will be up to the Historical society. Wished there were some Sons of the Revolution present at Heritage Days to shoot musket.
- Creek Clean-Up with Lyn White at Dudley Woods 10/26. Rick has not received any info. We need general info from Lyn.
- Fossil Walk – possibly at Cherokee 5/2/2020 with Lyn.
